There were two other individuals in the car. Officers smelled the odor of marijuana emanating from within the vehicle. Williams gave UConn officers consent to search the vehicle and during the search, UConn officers found Williams in possession of approximately 4 grams of marijuana and a loaded BB gun which appeared to be an actual firearm and did not have an orange tip/markings indicating that it is a BB gun. This weapon was within reach of the driver. Williams, who is under the legal drinking age of twenty one years old, was also in possession of an open container of vodka. Williams was subsequently placed under arrest at 2230 hours.
