THE DEFENDANT WAS OPERATING THE LISTED VEHICLE IN THE PARKING LOT OF ROYAL PALM TRAILER PARK, 720 S. FEDERAL HWY. THE DEFT. REACHED THE EXIT OF THE PARKING LOT, WHICH EXITS ONTO S. FEDERAL HWY., AND FAILED TO COME TO A COMPLETE STOP BEFORE PULLING ONTO S. FEDERAL HWY AND PULLING ACROSS THE RIGHT THROUGH LANE OF SOUTHBOUND TRAVEL, WHERE THE DEFT. CAME TO A STOP, BLOCKING THE LANE. VICTIM MARTINEZ SOLARES, TRAVELING SOUTH IN THE RIGHT THROUGH LANE, WAS FORCED TO CHANGE TO THE CENTER LANE AND CONTINUED TO TRAVEL

Probable Cause Affidavit

Before me this date personally appeared WILLIAMS, ERIC (6012) who being first duly sworn deposes and says that on 10 day of May (year) 2018 at 700 S FEDERAL HWY, HALLANDALE BEACH, FL 33009 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

SOUTH. AS VICTIM MARTINEZ SOLARES PASSED, PERPENDICULAR TO THE DEFT., THE DEFT. SUDDENLY ACCELERATED AND STRUCK THE RIGHT FRONT OF VICTIM MARTINEZ SOLARES 2005 MERCEDES CAUSING APPROXIMATELY \$8,000 DAMAGE. AFTER IMPACT, THE DEFT. CONTINUED TO ACCELERATE, HOWEVER HIS TRAJECTORY WAS NOW IN A SOUTH EASTERLY DIRECTION. THE DEFT. STRUCK THE RAISED CONCRETE DIVIDER MEDIAN, TRAVELING OVER SAME, AND STRIKING VICTIM ALVAREZ DE LIMA, A PEDESTRIAN THAT WAS STANDING ON THE MEDIAN.

AFTER THE DEFT. STRUCK ALVAREZ DE LIMA, SHE WAS THROWN BACKWARD, ONTO THE HOOD OF THE DEFT. VEHICLE AS THE VEHICLE CONTINUED IN A SOUTH EASTERLY DIRECTION. WHILE THE DEFT. VEHICLE CROSSED THE MEDIAN, THE VEHICLE ALSO DAMAGED SHUBBERY OWNED BY THE CITY OF HALLANDALE BEACH. AFTER CROSSING THE MEDIAN, THE LEFT FRONT OF THE DEFT. VEHICLE STRUCK THE LEFT REAR OF A 2010 FORD ESCAPE, OPERATED BY VICTIM BOLIVAR, THAT WAS TRAVELING NORTH ON S FEDERAL HWY. IN THE LEFT THROUGH LANE. THERE WAS APPROXIMATELY \$2,000 DAMAGE TO VICTIM BOLIVARS VEHICLE AS A RESULT OF THIS IMPACT.

THE DEFT. CONTINUED FORWARD MOMENTUM AND STRUCK THE LEFT SIDE OF A 2016 NISSAN ROGUE, BEING OPERATED BY VICTIM RAYMON, IN THE CENTER THROUGH LANE OF S FEDERAL HWY. THIS CAUSED APPROXIMATELY \$15,000 DAMAGE TO THE VEHICLE AND SERIOUS BODILY INJURY TO VICTIM RAYMON WHICH NECESSITATED HIS HOSPITALIZATION.

THE DEFT. CONTINUED SOUTHEAST AND STRUCK THE LEFT FRONT OF A 2017 DODGE RAM VAN, BEING OPERATED BY VICTIM HENRY, IN THE RIGHT THROUGH LANE OF S. FEDERAL HWY AND CAUSED APPROXIMATELY \$9,000 DAMAGE.

THE DEFT. AND HIS VEHICLE CAME TO REST AFTER THE FINAL IMPACT, AT WHICH TIME VICTIM


